This Dental Hygiene Committee of California approved course in Expanded Duties for the Dental Hygienist includes the administration of Nitrous Oxide, Local Anesthesia and Soft Tissue Curettage. All three certifications must be completed concurrently. Participants must be a licensed Dental Hygienist from a USA or Canadian approved program, or a senior hygiene student. All participants must be certified in CPR prior to the beginning of class.

Our course also includes Dental Board of California Infection Control, and a CDPA (Ethics) course.

Please be prepared to provide copies of the following **via e-mail** at least 1 month prior to the first class meeting :

1. Proof of current CPR certification
2. Proof of current State licensure **OR** status as a **last semester, senior** hygiene student
3. Proof of malpractice insurance (you **MUST** have your own coverage... minimum one million dollars)
We utilize a company called CM&F Group, Inc., however you may use whomever you wish as long as the above requirements are met.

• All lectures and tests are in an online format. You will need high-speed internet. Completion of all online lectures and examinations must occur at least two weeks prior to the start of the face-to-face portion of the course.

•Because of the use of Nitrous Oxide, we do not advise that this course be taken by individuals who are pregnant in first or second trimester.

Things you should know about the course!

We know that this will be a somewhat stressful experience for some of you simply because you are traveling a long distance in order to attend the course. We try to make it as pleasant an experience as possible, but we need your help.

You need to be fully prepared for the course and follow our requirements for; patients, schedule, and required instruments. The California Dental Hygiene Committee has specific requirements for certification in Expanded Duties. We are required to meet those standards.

1. You MUST provide THREE outside patients. One for each clinical session (Days 5,6). *You will perform all three procedures on the three patients. On day 4, you and your partner will be patients for each other.*
2. We provide all of the consumable supplies such as anesthesia, gauze, barriers, needles, gloves, masks, disposable gowns, etc.
3. You are required to provide ALL of your own instruments to clean your patients' teeth. *We will be providing the mini Gracey required for STC and the aspirating syringe for local anesthesia.* OSHA attire such as scrubs must be worn under disposable gowns. **Wear scrubs to ALL class sessions.** We have ultrasonic units at your disposal, but you are required to provide your own 30K tip inserts.
4. You must have ALL your instruments in an **instrument cassette (s)** appropriate for the number of instruments you are using. PLEASE DO NOT BRING EXTREMELY LARGE CASSETTES.
5. We provide pdf files for your handouts that go with our on-line lectures. Make sure you complete ALL the online course work and examinations **two weeks prior to the first day of class.**
6. Each pair of students must work together during the entire 4 clinical treatment sessions. Be considerate, thoughtful and on time. If you arrive late, your laboratory partner cannot proceed.
7. The airport is only about 15-20 minutes from the facilities, but assume that you will be in the clinic until the hours listed on the schedule on page 3.
8. We will gladly keep your instruments for you in our facility between weekends so that you don't have to deal with TSA or possible theft from your luggage.
9. You will receive the paperwork you need from us in order to file your application to become licensed in California on the last day of class. Make sure in the meantime you complete all the remainder of the application and get your LiveScan done as soon as possible.

What supplies and materials will I need to bring?

For all subjects

We can not loan instruments. If you do not have instruments, you can purchase them from a dental supply house or borrow them from a dental office. Bring all required instruments to class the first day! **We have sterilizers** and will sterilize items for you when you arrive if needed! The program will supply all consumable supplies such as anesthesia, topical, barriers, needles, gauze, gloves and face masks, gowns, etc. **We will also be providing an aspirating syringe, mini Gracey 15/16, mirror and small cassette for those instruments.**

About Patients

How do I obtain patients?

Probably the one item that causes the most stress in this course is "getting patients!" The program **cannot** provide patients. It is the responsibility of the students to provide their own clinical patients. The following information may help. We do NOT advise using CRAIG'S LIST TO OBTAIN PATIENTS. Students have had some bad experiences with obtaining patients in on-line websites.

- Bring relatives or friends as your patients.
- Entice your prospective patients by telling them that you will do the work for free plus give them \$50 to be your patient. (Only pay **after** the work has been done.)
- If anyone has extra friends that need treatment, please bring them to the clinic with you for other less-fortunate students.
- If you have any contacts in the area, see if they can help.

What are the patient requirements?

Three outside patients are needed, one for each of the clinical sessions on days 6,7. You and your lab. partner will be one of the patients for each other on day 4. On day 5 bring two outside patient . One for the AM session and one for the PM session. On day 6 there is one AM session for 1 additional patient. If you have a patient that is willing to be seen twice... ..Bring them the last weekend for both days (days 5/6). We will explain how this works in class the first day.

You will perform STC, Local Anesthesia and Nitrous Oxide on all (three outside patients)

What are the appointment times for the patients?

Patients should plan to arrive at the clinic by 7:45 in the morning or 1:00 in the afternoon. More specific times will be discussed the first day of classes.

How much time should my patient expect to be at the clinical facility

Most patients require about 1 1/2 -2 hours from the time you are ready to start your treatment. If you need to take x-rays, allow some additional time.

We have x-ray facilities, and sterilizers.

What are patient requirements?

All patients **MUST** be at least 18 years old. Patients with significant medical problems can **not** be seen. This may include **high or uncontrolled blood pressure, uncontrolled diabetes, uncontrolled heart disease, patients on anticoagulants, patients on immunosuppressant drugs, or pregnant patients.** Individuals that are bi-polar or being treated for significant depression or any kind of emotional/ anxiety conditions are **NOT** good choices for the use of nitrous oxide, **DON'T bring them!** Patients that need antibiotic premedication should be medicated as needed.

SOFT TISSUE CURETTAGE PATIENTS

You will be required to perform soft tissue curettage on several teeth. You need three patients. You will see one of these patients each clinical session on the last two days of the course. These patient should have appropriate **x-rays** and a complete **periodontal charting** prior to starting the procedures. Probing will be performed in our facility prior to your assigned appointment. X-ray facilities are also available, however it is best if you already have x-rays for the patient.

Because of the difficulty in obtaining patients, we will accept a "warm body with teeth" that is willing to have STC, anesthesia. and nitrous.

We have our own Health Histories which must be used for all patients.
